For breach of this agreement, or any damages caused by defective, damaged, or malfunctioning goods sold to or to be sold under this agreement, the buyer agrees to be limited to the repair or replacement of the goods, or the refund of the purchase prices at the seller's option, as the sole and exclusive remedy. Seller shall not be liable for any incidental or consequential damages.

Discounts are allowed as stated on the invoices if paid by the 10th of the month following billing, Net 15th of month and considered past due thereafter. All payments are payable at 2526 N. month, not to exceed 18% per annum. It is also understood and agreed that if this sale is placed in the hands of an attorney, and/or collection agency, the Buyer agrees to pay all expenses, including court costs, legal and administrative expenses, attorney and/or collection agency fees paid or incurred by ELLIOTT ELECTRIC SUPPLY.
